While purchasing a tender form, contractor/Firm should submit a certified true copy of Registration, (Civil), GST Registration Certificate, PAN Card, Income Tax Return Certificate for the past three years, list of work completed during last three years, and list of work in hand under Government or semi government departments/corporation, and private sectors. The registered contractor must have satisfactorily completed building works of 75 % more than estimated cost in last one years under a single work order and an un-registered contractor must have satisfactorily completed a building works of 95 % more than estimated cost in last one year.

While purchasing a tender form, contractor should bring all original certificates that are mentioned above with him/her. The tenderer/firm should submit an affidavit on stamp paper worth Rs. 100 before Notary (or self-attested) stating that the tenderer is not black listed in any of the Departments of Government and Semi Government, corporation sector within a year.
